Scope

This document describes upcoming changes to the FAADC XML and Web Services Specifications in Version 1.2 release.

For a detailed description of the existing specifications, please refer to the 'FAADC Webservices Specifications V1.1' document and XML Schema specifications on the FPDS project website (<http://www.fpds.gov>).

The finalized Version 1.2 FAADC XML and 'FAADC Web Services Specifications V1.2' will be published on the FPDS project website.

Background

The following functional changes are being implemented as part of Version 1.2 FAADC services:

- Add new data elements to allow multiple Assistance Listings to be tracked on one record
- Add new data element to identify *discretionary* Grants and Cooperative Agreements
- Rename *CFDA* to *Assistance Listing*
- Used generic tags to be assigned their own name tags:
 - *fundingOpportunityGoalsText*
 - *indirectCostFederalShareAmount*
 - *isJointVentureSmallBusiness*
 - *isSBACertifiedWomenOwnedSmallBusiness*
 - *isSBACertifiedEconDisadvWomenOwnedSmallBusiness*
 - *isJointVentureServiceDisabledVetOwnedBusiness*

The Version 1.2 functionality requires changes to the XML specifications. The following sections describe the changes in detail.

Executive Summary

The following are major changes in Version 1.2 FAADC XML specification:

Assistance Listing Changes:

- Add *listOfProgramInformation*
- Remove '*correctionDeleteIndicator*' from *assistanceIndicators* and move to *programInformation*

- Move *programInformation* under *listOfProgramInformation* with the following changes:

 - Add the following fields:
 - '*isPredominantAL*'
 - '*ALFederalActionObligationAmount*'

- *'ALNonFederalFundingAmount'*
 - *'ALFaceValueOfDirectLoanOrLoanGuaranteeAmount'*
 - *'ALOriginalLoanSubsidyAmount'*
 - *'ALFABSSentDate'*
- 'Add new data element **1K** *'Discretionary'* to *assistanceData*
- Change 1.1 CFDA.xsd to 1.2 AssistanceListing.xsd

Assistance Listing Search Changes:

- Update *assistanceSearchCriteria* to rename *'CFDANumber'* to *'ALNumber'*
- Update *assistanceSummary* to replace *'CFDANumber'* with *'listOfProgramInformation'*

Generic Fields to Named Fields:

- Update Data Element **1J** xml tag name from *'genericString01'* to *'fundingOpportunityGoalsText'*
- Add *'fundingOpportunityGoalsText'* to *assistanceData*

- Update Data Element **4G** xml tag name from *'genericFloat01'* to *'indirectCostFederalShareAmount'*
- Add *'indirectCostFederalShareAmount'* to *dollarValues*

- Update Data Element **11CJ** xml tag name from *'genericString03'* to *'isSBACertifiedWomenOwnedSmallBusiness'*
- Add *'isSBACertifiedWomenOwnedSmallBusiness'* to *vendorCertifications*

- Update Data Element **11CK** xml tag name from *'genericString04'* to *'isSBACertifiedEconDisadvWomenOwnedSmallBusiness'*
